Umthengi uyavuma ukuba kukho ilungelo lokwandisa iNdawo ngokwemiqathango yeCandelo 25 loMthetho weCandelo lobuNini mhlaba ka1996. Umthengi kwakhona uyaqonda ukuba wazisiwe ngeli lungelo yi-Arhente kunye noMthengisi (**Cima ukuba akungeni oku**)

## 1. IMEKO YENDAWO

- 1.1 Umthengi akazi kubanoxanduva lwayo nayiphi into engamanga kakuhle kule Ndawo nokuba kukwimeko ekhoyo ngoku okanye esaza kubakho, kwaye kwakhona akayi kubanoxanduva lokwenziweyo, imeko nendlela yokwakha okanye ekufakwe ngayo izinto kule Ndawo. Le ndawo ithengiswa "ngokoxanduva lwakho" kwaye ikwimeko ekuyo ngoku kwaye ixhomekeke kwiimeko zonke zendawo yokuhlala. Umthengi uyavuma ukuba umthengi sele esazi ngokupheleleyo ngeMpahla kwaye uyavuma ukuba umthengi akaqhutywanga ukuba angene kwesi sivumelwano nangaluphi uhlobo okanye ngokumelwa yiLucas Real Estate okanye nawuphi na omnye umntu, nokuba ngu okanye egameni lomthengisi.
- 1.2 Isaziso esiqhotyoshelweyo apha, ephawulwe "IsiHlomelo B" nesisayinwe nguMthengisi, siyinxalenye yesi sinekezero. Akukho nto equlathwe kwesi saziso ekufuneka itolikwe ngenye indlela njengesithembiso sembuyekezo yalo naluphi na uhlobo nguMthengisi. Ukuba uMthengisi akakwazi okanye akufuni ukunika intetho enjalo, oko kuyakucaciswa kumthengi. Ngaphandle kokuba kuchazwe ngenye indlela kolu xwebhu, umthengisi akanaxanduva lwazo naziphi na iziphene ezikhoyo okanye ezizakubakho kule ndawo, ngalo mhla wentengiso okanye ezivele emva koko, okanye iindleko zokulungisa naziphi na iziphene ezinjalo kunye / okanye nawuphi na umonakalo ofunyenwe nguMthengi ngenxa isiphako ezinjalo, eqonda ukuba ukuba indawo ibithengiswa ngokoxanduva lwakho (njengoko injalo). Kwakhona uMthengi uyayazisa into yokuba uthe waziqhelanisa nentsingiselo kunye neziphumo zoko.
- 1.3 Nasiphi na isiphoso kwesi sivumelwano ngokwenkcazo okanye ubungakanani beNdawo abusenzi esi sivumelwano singabisiso okanye asiniki mbuyekezo kulo naluphi na iqela.
- 1.4 UMthengisi uyakufuneka abonise kuphela kuMthengi indawo yeziphawuli mhlaba noonocanda ezikuloo Ndawo kunye/okanye imida futhi athathe uxanduva lweendleko zokususa oku ukuba sisiza esingenanto.
- 1.5 Umthengisi akayi kwazi nto ngezakhiwo ezakhiwa kule Ndawo ukuba azikho kwiplani epasisiweyo nebhaliweyo. Uxanduva lokunika iplani epasisiweyo nebhaliweyo iyakuhlala iluxanduva loMthengisi kwaye zonke iindleko ezinxulumene ekufumaneni iiplani ezinjalo ziya kuthwalwa nguMthengisi. Kwimeko yentengiso eyenziwa kwindawana ethile yeyunithi uMthengisi wazisa ukuba zonke iindawo ezifakelelweyo zipasisiwe liBhunga loLawulo kunye nee-Arhente ezilawulayo nokuba zonke ezo ndawo zifakelelweyo zivunyiwe nguNocanda Jikelele nakwiGunya loLawulo lasekuHloleni elifanelekileyo. Ukulawula zonke izandiso ezo zibhalisiwe kwi-Surveyor- Jikelele kunye neGunya Local echaphazelekayo. Ukuba kunokuthi kufunyaniswe ukuba izandiso ezo nto ibhalisiwe kwi yoMhlobo-Jikelele umthengisi uya kuba noxanduva ukubhalisa ezintanjeni ezinjalo kwaye uya kuba noxanduva lokuhlawula iindleko ezinxulumene noko. Xa kuthe kwafunyanwa ukuba ezo ndawo zifakelelweyo azibhaliswanga kuNocanda Jikelele,, uMthengisi uzakuba noxanduva lokubhalisa ezo ndawo, aze kwakhona athwale iindleko ezidibene noko.
- 1.6 Umthengi uqinisekisa ukuba uyihlole ngokupheleleyo loo ndawo ngaphambi kokuba asayine olu xwebhu, akuba enikwe ithuba elaneleyo lokwenza njalo kwaye uMthengi waneliseke ngandlela zonke yile Ndawo ngaphandle kwemiba echazwe ngenye indlela kolu xwebhu.

Eso siqinisekiso siza / ezo ziqinisekiso ziza kuthunyelwa nguMthengi kwiintsuku ezili- 14 (ishumi elinesine) zicelwe ngaMagqwetha, apho eso sicelo singenziwa nangaluphi na ixesha kodwa ingelilo ixesha elingaphambi kokuphelelwa kweemeko ezifumaneka kwesi sivumelwano.

- 2.3 UMthengi uya kunika ubungqina bezimali obanelisayo kuMagqwetha kwiintsuku ezi 3 (ezintathu) esayine ngokubhekiselele kwizimali ezisetyenziswe ukuhlawula idiphosithi OKANYE ukuhlawula ixabiso lokuthenga elipheleleyo, ukuba esi sivumelwano siphantsi komhlathi 6.1 nokuba sisiqendwana 12.1.
- 2.4 UMthengisi uqinisekisa ukuba ixabiso lokuthenga lanele ukuquka iintlawulo zonke ezishiyekileyo zendlu, iintlawulo zee-Arhente, iintlawulo ezithile zendlu, iirhafu, umbane, amanzi kunye nentlawulo yokusebenzisa izinto, kwakunye nezinye iintlawulo ezibekwa liGunya elisekuHlalani, iBhodi yoLawulo okanye nawuphi uMbutho wamaNini-Mizi.
- 2.5 **Ukuba uMthengisi ubhaliswe-kwiRhafu yeNtegiso [VAT], ngokwenjenje kuyavunyelwana ukuba intengiselwano iza kutsala iRhafu yeNtegiso –VAT, hayi iNtlawulo yokuSuswa kobuNini. ### 3 UKUHLALWA KWENDAWO

- 3.1 Ngaphandle kokuba umthengi uzihlawule zonke iindleko, wasayina onke amaxwebhu etyala lendlu, wazisa zonke iziqinisekiso njengoko esenokucelelwa oko, zonke iimeko ebezimisiwe zifezekisiwe, zonke iziqinisekiso zokuThobela njengoko kufunwa ngokubhekiselele kwesi Sinikezelo sokuThenga, zikhutshiwe kwaye uMthengi akophulanga mthetho kokukhona, ilungelo lokuhlalwa kwendawo liza kunikwa uMthengi kwaye lithathwe kwanguye ngentsimbi ye-12 emini emaqanda.

Ukuba umhla wokuhlala kule ndawo awungqamani omhla wokuqala ukuhlala akuthethi lingqamane nosuku lokutshintshwa kobunini, lowo ufumana ilungelo lokuhlala lo gama iNdawo isabhaliswe egameni lomnye, uzakuthi aqwalaselwe, kwaye ngexesha ahleli ngalo, uzakuhlalwa aMagqwetha irenti engama R \_\_\_\_\_ ngenyanga, ehlawulwa ngaphambi kokuhlala ukusukela ngomhla wokuqala ukuhlala, ibalwa ngosuku. UMthengi akayi kuzenza ngathi uqeshe indawo kuba ehleli kulo ndawo ngaphambi kokuba isuswe kumnini ndawo, yaye ilungelo lokuhlala koMthengi lizakunqunyanyiswa kukuyekwa kwentengo nangasiphi na isizathu.

Ukuba ilungelo lokuhlala alingqamani nomhla wokubhalisa utshintsho lwendawo, lowo uhlala kuloo Ndawo, lo gama ibhaliswe ngegama lomnye umntu unoxanduva lokuhlalwa zonke iintlawulo zamanzi nombane ezithe zahlawuliswa le Ndawo ukusukela ngomhla eqala ukuhlala. - 3.2 Umthengi akayi kuba nelungelo lokwenza naluphi na utshintsho okanye ongeze okuthile kule Ndawo ngaphandle kwemvume ebhaliweyo yoMthengisi. UMthengi uzakufanela ukuba, xa ethe wacima isivumelwano, ashiye iNdawo leyo kwaye ayibuyisele kuMthengisi ikwimeko eyayikuyo xa uMthengi wayeqala ukuhlala kuyo. Kwakhona uMthengi akayikuba nebango nangayiphi indlela kuMthengi, kuba enze utshintsho oluthile kule Ndawo.

- 3.3 INdawo iyakunikwa uMthengi ingenanto, inikezelwa nguMthengisi ngomhla wokuqala ukuhlala. **(Cima ukuba kuyimfuneko)**

3.4 Kuyavunyelwana ukuba akukho sivumelwano sakuqesha le ndawo senziwayo ngenxa yalo mhlathi kwaye xa intengo ithe yacinywa okanye yaphelwa nangaso nasiphi na isizathu, uMthengi uyakufanela ukuba ashiye loo ndawo mhlawumbi aphume ngoko nangoko okanye ngomhla ekuvunyelwene ngawo ngembalelwano yamaqela omabini alapha.

### 4 INZUZO NOMNGCIPHEKO

Yonke inzuzo nomngcipheko kule ndawo uza kudlulela kuMthengi xa kutshintshwa yaye ngalowo mhla uMthengi uzakuba noxanduva lokuhlalwa, phakathi kwazo kukho zonke iintlawulo zendawo, irhafu kunye/ neentlawulo zale Ndawo. Iintlawulo ezenziwa ngaphambi kwenkonzo, zisenziwa lilo naliphi iqela, ngexesha elilandela utshintsho lwendawo ziza kulungiswa kakuhle. UMthengisi uyakugcina i-inshorensi ekhoyo kule Ndawo kude kutshintshwe, apho aya kuthi uMthengi abenoxanduva lokuthatha aze agcine i-inshorensi efanelekileyo.

### 5 UTSHINTSHO

- 5.1 Utshintsho luyakwenziwa ngaMagqwetha obunini ndawo oMthengisi ngomhla \_\_\_\_\_ wenyanga ka \_\_\_\_\_ kunyaka u20 \_\_\_\_\_ okanye ngokukhawuleza, ukuba uMthengisi ulandela okuqulethwe kumhlathi 2.1 no2.2 waza wasayina onke amaxwebhu otshintsho xa efunwa ngaMagqwetha obunini ndawo. UMthengisi uyakuthi xa kufuneka, ukuba aMagqwetha afuna ngolo hlobo awahlawule eso sixa nanjengoko kungafuneka isiqinisekiso seentlawulo zendawo leyo ukuze kuquzelelwe utshintsho.

- 5.2 UMthengisi ugunyazisa iGqwetha lobunini ukuba lifumane iifunono zokususwa kweenkcukacha kumasipala, kuquka ityala ekungenzeka ukuba belifudula likhona nebelihlawulwa kumasipala, njengoko kufuneka ngokubhekiselele kwicandelo 118 (1) no 118 (3) woMthetho weeNkqubo zikaMasipala wama-32 ka-2000. Nawaphi na amatyala enzeke ngenxa kamasipala, aza kuchazwa ngaMagqwetha obunini ndawo, ngokujonga uhlobo lweentlawulo ezisuka kwigunya lolawulo lwasekuhlaleni yaye xa uMthengi ethe wangagunyazisi aze ayalele ukuba aMagqwetha ahlawule loo matyala kumasipala xa kuqhutywa intengo, oko kuzakuthathwa njengokuba uMthengi waphule isivumelwano, yaye kuza kusetyenziswa okufanelekileyo xa kwaphulwe isivumelwano okufumaneka kuMhlathi 16. Ukuba uMthengi uyarhoxa ngenxa yokuba uMthengisi engakwazi ukulungisa oko akophulileyo, uMthengisi akayi kufuna mbuyekezo yawo nawuphi na umonakalo athe wawufumana kuMthengi. UMthengi naye akayi kubanelungelo lokubuyekwezwa nguMthengisi nangayo nayiphi na ilahleko athe wayifumana ukuba urhoxe ngenxa yokuqulethwe kulo mhlathi.

### 6 ITYALA LENDAWO

- 6.1 Le ntengiso ixhomekeke kuMthengi ungadlulanga umhla we \_\_\_\_\_ ukuze akwazi ukukhusela ityala lendlu kwiNdawo, efuna imali mboleko yama R \_\_\_\_\_ ( \_\_\_\_\_ ) (okanye imali encinanana nanjengoko uMthengi engavuma) kwiimeko ezinjalo kwaye ngokubhekiselele kwezo meko, njengoko kwabekwe kanjalo ngamaziko abolekisa ngemali yokuthenga indlu. UMthengi ugunyazisa ukuba uyazi ukuba akukho nto ithintela ukuba ukuba iziko lezimali likhuphe ikowuti yemali mboleko. Le meko izakuba ifezekisiwe ngomhla apho lowo ubolekisa ngemali ethe wakhupha ikowuti yemali mboleko ebhaliweyo (ngokubhekiselele kuMthetho waMatyala weLizwe wama 34 ka 2005) ngokwaloo mali mboleko. Kodwa ukuba iziko lezimali liyarhoxa ukunika imali mboleko yaye oko kurhoxa kungenziwa kukuziphatha, ukungenzi kakuhle okanye ukungahoyi koMthengi, esi sivumelwano siyakuthi siphelwe ke. Ukuba ikowuti yemali mboleko ayikhutshwanga ngalo mhla kuthethwa ngawo apha ngasentla, ixesha lokufuna imali mboleko liya kwandiswa ngentsuku ezingama 30 (Amashumi amathathu).
- 6.2 UMthengi uzimisele ukwenza konke okusemandleni akhe ukuba siphumelele isicelo semali mboleko. Kwakhona uMthengi uzimisele ukunika iGosa leMali mboleko yeziNdlu onke amaxwebhu afunekayo kwiintsuku ezisi 7 ecelwe lilo. Ukuba uMthengi uyafelisha ukufumana imali mboleko mgenxa yokungaqhubi kakuhle kwiintlawulo zakhe okanye ukungahoyi koMthengi, esi sivumelwano siya kubophelela uMthengi kukhetho lwalowo unguMthengisi. Ukuba uMthengi akaniki maxwebhu afunekayo, kwaye enze iSicelo esiFanelekileyo xa eceliwe, uMthengi uzakuba noxanduva lwawo nawuphi na umonakalo ethe i-Arhente okanye uMthengisi wawufumana ngenxa yoMthengi owaphule isivumelwano salo mhlathi.
- 6.3 Okufumaneka kumhlathi 6.1 kuyinzuzo yoMthengi okungathi kumise imeko ngokucacileyo okanye ngendlela yokwenza.
- 6.4 Le mali mboleko ikhankanywe apha izakufunwa ngokwemali mboleko yendlu eza kubhaliswa kuloo Ndawo ngaxeshanye nobhaliso lotshintsho lwendawo.
- 6.5 Ukuba uMthengi uthetha nangingaphi na ixesha, ngaphambi kokufezekiswa kwale meko, wakhetha ukumisa le nzuzo okanye wamkela ikowuti esuka ebhankini okanye kwiziko lezimali iyeyesixa esingaphantsi kwesixa esichazwe kuMhlathi 6.1, uMthengi uzakunika iGqwetha loMthengisi isiqinisekiso sebhanki (okanye afake isixa eso kwi-Akhawunti yaMagqwetha oMthengisi) semali ephelileyo, ngokoMhlathi 6.1 okanye umahluko phakathi kwesixa esivunyiweyo setyala lendlu kunye nesixa esikuMhlathi 6.1 njengoko kungenzeka, kwiintsuku ezili 14 kumiswe le meko okanye kwamkelwe isixa esiphantsi setyala lendlu.
- 6.6 **Umthengi utsalwa ukuba abone umba wokuba, ngokwemeko ekukholelwa kuyo, lo mhlathi uyakuba ufezekisiwe ukuba umthengi akavumi ukufikelela lula kulo mhlathi nangayiphi na indlela.**

## 7 ISIQINISEKISO SOKULANDELA IMIGAQO YOMBANE

UMthengisi uzakunika uMthengi, ethumela ngaMagqwetha, iSiqinisekiso sokuLandela imigaqo yoMbane [Electrical Compliance Certificate], esikhutshwe ngokwemigaqo yomthetho weNombolo 2920 yonyaka 1992, oLawulayo kaRhulumente [Government Regulation], kungadlulanga usuku lokutshintshwa kwamagama okanye xa kuthe kwafunwa oko ngamagqwetha emihlaba, nokuba yiyiphi ekhawulezayo. Ngokubhekiselele kwigcisa lezombane eligunyazisiweyo, eliqeshwe nguMthengisi ukuze linike eso siqinisekiso, xa kufuneka ulungiso okanye ukubuyiselwa komsebenzi wezombane kufuneka oko kwenziwe kuqala ukuze kukhutshwe isiqinisekiso, uMthengisi uza kulungiselela ukuba lowo msebenzi wenziwe kwaye uzakwenza oko ngeendleko zakhe. Isiqinisekiso asiyi kuba sesomhla ongaphambili komhla ekuvunywe ngawo ngaphezu kweenyanga ezi 3 (ezintathu). Ukuba iziko lezeZimali lifuna isiqinisekiso esisiso nesitsha ukuba sikhutshwe, uMthengisi uzimisele ukuhambisana nalo migaqo, ngeendleko zakhe.

## 7. ISIQINISEKISO SOKUHLOLWA KWEZINAMBUZANE (Cima ukuba kuyimfuneko)

UMthengisi uzakuthi ngaphambi kokuba kuhlalwe kuloo ndawo anikezele, kumagqwetha obunini, ngokweendleko zakhe, ngokubhekiselele kuloo Ndawo ithengisayo, iSiqinisekiso, esingekho ngaphezu kweenyanga ezi 3 (ezintathu) ukusukela ngomhla olapha, esisuka kwilungu loMbutsho oLawula iZinambuzane woMzantsi Afrika, ukuba wonke umsebenzi weplanga okwisakhiwo ekuhlalwa kuso kunye nezakhiwo ezingaphandle, ezingathi zibonakale, awunazo izinambuzane ezitshabalalisa iplanga, kuquka ezi kodwa ingezizo zodwa: hylostropes, bajulus, Anobium Punctatum okanye oxyleurus nodieri. Ukuba kukho amanye amaplanga afunyenwe ehlaselwe ngamabhungane, uMthengisi uyakuthi ngeendleko zakhe afafaze ukuze kubulawe izinambuzane njengoko kukhuthazwa oko, aze athi kwakhona ngeendleko zakhe alungise amaplanga athe achaphazeleka. Olo hlolo luza kubeka bucala izibona okanye amaplanga ekubiywe ngawo, izindlu zeplanga kunye neeshedi ezenziwe ngeplanga.

## 8 ISIQINISEKISO SOKUFAKELWA IGESI (ISiqinisekiso sokuLandela)

- 23.2** Kwimeko apho uMthengisi engenayo itayitile kuzo naziphi na iindawo ezibekwe bucala ezikhankanywe apha, kubhaliwe ukuba uMthengisi akanawo amalungelo abucala okusebenzisa ezo ndawo ngokubhekiselele kwimithetho yeBhodi yoLawulo elawula iQumrhu elo, njengomnini wendawana/iindawana ezithengiswa apha.
- 23.2** Kwimeko apho iBhodi yoLawulo ithi kwiintsuku ezingama 30 (amashumi amathathu) emva kokubhaliswa kotshintsho, yafaka umrhumo okhethekileyo ukuze kufikelelwe kwiindleko ezithe zaqikelelwa ngaphantsi zalo naliphi na ixesha ukuya kwixesha lobhaliso lotshintsho, uMthengisi uzakubuyisela uMthengi eso sixa mali ngoko nangoko ngelo xesha lowo mrumo kufuneka uhlawulwe uMthengi.

## 24 ISIGUNYAZISO SERHAFU
